

St. Mary's PCCW Meeting Minutes

Date: January 17, 2023

Time: 6:00 pm

Place: St Mary's

The meeting called to order at 6:00pm by President, Jeni Whitwam. Guest, Father Bosco lead us in the Our Father.

The agenda was adjusted, so our guest Father Bosco could speak and then leave the meeting.

Father thanked St Mary's so much for all of the prayers and monetary support we have given to his parishes. Since they do not receive any assistance from the government; our money helps to provide food, health and educational assistance to the parish members.

Secretary's Report:

Treasurer's Report:

An amended treasurer's report from July 1st to November 30th was given to the PCCW officers at the beginning of our meeting. The treasurer's report from November 17th, 2022 to January 17th, 2023 stated a balance of \$20,644.08. We had an income of \$576.45 and our expenses for that period were \$1703.70. Our ending balance is \$19,516.83. B. Kallstrom made a motion to accept the report and R. Prissel 2nd the motion. All present agreed.

Missy also read a thank you note from Emma Weiss for the scholarship she received from the PCCW.

Old Business

Ash Wednesday Fish Fry: Paul and Jodi Weisenbeck will be taking the lead role in St Mary's fish fries. St Lucy and St Ann's groups will be helping for Ash Wednesday. We will only offer a 3 piece dinner with all of the sides for \$14. It will be a walk through format. The customer can then enjoy their meal at St Mary's, or take it to go. There will be no drive through this year. Jodi will give fish fry instructions and sign-up sheets for volunteers to the 2 groups' leaders.

If all goes well, we will then have a Good Friday fish fry with St Martha and St Catherine's groups assisting.

New Business

Deanery Youth Rally Donation: B. Kallstrom made a motion that we donate \$400 towards the rally and also pay for the doughnuts, that Monica will purchase. S. Snyder 2nd the motion and all present agreed.

Youth Group Meal on March 29, 2023: Jeni Whitwam suggested a meal of walking tacos, cookies and water. J. Spindler made a motion to purchase the water and items needed for tacos. C. Drumheller 2nd the motion. All agreed. PCCW members will gladly make cookies for the event. Jeni will send out a text/email to remind us of the cookie donation.

Church Cleaning: Jeni stated that she got a quote of \$1500 to clean the carpets and tile of the church. All PCCW members approved. It was suggested that we wait to have the church cleaned until springtime.

Fellowship for 2023: Jeni passed around a sign-up sheet for fellowship after the 8am Sunday Masses. Each group should sign-up for a time slot.
